

## **CIRCULAR**

No.F. 7(3)FD(Rules)/98

Jaipur, dated: 2.8.2006

Subject: Instructions regarding admissibility of transfer T.A. and Joining Time.

Under Rule 2(7) of Rajasthan Travelling Allowance Rules, 1971 and Rule 4 (1) of Rajasthan Civil Services (Joining time) Rules, 1981 the provisions regarding 'TA' and 'Joining Time' on transfer in public interest are as under:

- (a)"2(7) Transfer means a transfer of a Government servant in the public interest from one headquarter station in which he is employed to another such station either to take up duties of a new post or in consequence of a change of the headquarters of his post."
- (b)"4(1) Joining time shall be granted to a Government servant on a transfer in public interest to enable him to join the new post either at the same or a new station. No joining time is admissible in case of temporary transfer for a period not exceeding 180 days. Only the actual transit time, as admissible in case of journeys on tour, may be allowed."

When transfer is on official's request, no TA and Joining time are admissible.

It has been brought to the notice of the Government that large number of transfers of Government servants are being made on request. But no specific mention to this effect is being made in the transfer orders. This puts heavy burden on the State exchequer on account of transfer TA and Joining Time pay. www.rajteachers.com It is, therefore, enjoined upon all authorities competent to issue transfer orders of Government servants to ensure that in the order of transfer it is specially mentioned that the transfer is in public interest. In cases where no such mention is made in the transfer orders it will be presumed that transfer is on the request of the concerned Government servant and consequently no TA and Joining Time on such transfer will be admissible.

इस विभाग की समसंख्यक आज्ञा दिनांक 09 सितम्बर, 2016 द्वारा राजकीय अधिकारियों / कर्मचारियों के स्थानान्तरण / पदस्थापन में कार्य ग्रहण अवधि (Joining Time) देय नहीं होगी के संदर्भ में पूर्व प्रसारित आदेश में निम्नानुसार संशोधन किया जाता है:-

- प्रशासनिक आधार अथवा राज्यहित में किये गये स्थानान्तरण आदेश (चाहे उक्त आधारों का अंकन आलौच्य आदेशों में किया गया है या नहीं) वाले समस्त प्रकरणों में राजस्थान सिविल सेवा (कार्यग्रहण काल) नियम, 1981 नियम 4(1) के प्रावधानों के अनुसार कार्यग्रहण काल अनुझेय होगा।
- प्रशासनिक आधार अथवा राज्यहित का उल्लेख नहीं किये जाने वाले रथानान्तरण / पदस्थापन प्रकरणों में राजस्थान यात्रा भत्ता नियम, 1971 के प्रावधानों के अनुसार यात्रा भत्ता देय होगा एवं,

राज्य हित में किये गये स्थानान्तरण पर यात्रा भत्ता एवं कार्यग्रहण काल दिये जाने के संबंध में वित्त (नियम) विभाग द्वारा जारी निर्देश परिपत्र संख्या F.7(3)FD(Rules)/98 dated 2.8.2005 & F. 12(6)FD(Rules)/05 dated 21.08.2007 के अनुसार देय होगा ।

#### CLARIFICATION

No.F.12(6)FD(Rules)/05

Jaipur, dated: 21.08.2007

Sub.:- Clarification regarding joining time on transfer during the period of probation training of a probationer-trainee.

Attention is invited to Note 2 of FD Notification No.F.12(6)FD(Rules)/05 dated 13.03.2006, in which it has been provided that in case of transfer only Mileage Allowance and incidental on the basis of fixed remuneration shall be admissible.

A doubt has been raised that if a probationer-trainee is transferred during the period of probation training joining time under Rajasthan Civil Services (Joining Time) Rules, 1981 shall be admissible or not. The matter has been examined and it is clarified that if a probationer-trainee is transferred during the period of probationtraining he will be entitled to only Mileage Allowance and incidental on the basis of fixed remuneration and the provisions of Rajasthan Civil Services (Joining Time) Rules, 1981 shall not be applicable and the actual period required for travel will be treated as on duly.
