NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Pension) (Amendment) Rules, 2019.
- (2) They shall be deemed to have come into force with effect from 10.03.2019.
- 2. Amendment of rule 75.- In rule 75 of the Rajasthan Civil Services (Pension) Rule, 1996,-
 - (i) the existing sub-rule (2), shall be substituted by the following, namely:-
 - "(2) The amount of ex-gratia grant to the family of a government servant who dies in one of the circumstances mentioned in sub-rule (1) shall be as under:-

S. No.	Clause / Rule	Amount of ex-gratia grant
1.	Under clause (a) to (d) of sub-rule (1)	Rs. 20.00 Lac
2.	Under clause (e) of sub-rule (1),- (i) unfortunate event of death of the official.	Rs. 20.00 Lac
	(ii) If the death is unfortunately caused due to any violent acts of extremist or unsocial elements like, road mines, bomb blasts, armed attacks, etc.	Rs. 30.00 Lac

Provided that no extra relief shall be granted from sundry Government sources to families of deceased Government servants."

- (ii) the existing sub-rule (6), shall be substituted by the following, namely:-
 - "(6) Where a Government servant sustains permanent disability, like loss of limb, eye sight etc., in connection with election related duties, the amount of Ex-gratia grant shall be as follows:-
